**NOTICE OF THE SECOND (2<sup>ND</sup>) PUBLIC HEARING OF THE

LEWISTOWN BOROUGH, BROWN, DERRY AND GRANVILLE TOWNSHIPS  
FOR THE FEDERAL FISCAL YEAR (FFY) 2016 CDBG PROGRAM**

Notice is hereby given that the second (2<sup>nd</sup>) public hearing for the Mifflin County FFY 2016 Community Development Block Grant (CDBG) program (including entitlement municipalities of Granville, Derry and Brown Townships and The Borough of Lewistown), will be held by the Mifflin County Commissioners on **Thursday, October 6, 2016** at 9:00AM in the Commissioners' Meeting Room-A, on the second floor of the Mifflin County Courthouse, located at 20 North Wayne Street, Lewistown, PA 17044.

The purpose of the meeting will be to review the recommendations of the CDBG Advisory Committee held September 14, 2016 for Mifflin County CDBG funds only and to discuss which specific projects may be considered for funding by the 2016 CDBG allocations for the Borough of Lewistown, and Brown, Derry and Granville Townships. The draft FFY 2016 CDBG Program application will be available for public inspection beginning November 30, 2016 during normal business hours, in the Mifflin County Planning and Development Department at the address listed above. The final application will be submitted to the PA Department of Community and Economic Development (DCED) by December 16, 2016 by the Mifflin County Commissioners on behalf of the County, Brown Township, Derry Township, Granville Township and Lewistown Borough totaling **\$622,651**.

The following projects will be considered for funding consideration at the hearing and approved at the local level by resolution, at the public meeting dates listed below for each entitlement municipality. The public is encouraged to attend, comment and ask questions regarding each project and the tentative funding levels, up until the dates listed below for adoption of each project resolution and before the Commissioner's final adoption of the resolution for County CDBG funds only and for all entitlements scheduled for November 17, 2016.
